**GENERAL INFORMATION**

- All Passes will be available for pick up starting May 15, 2019 ONLY in the Membership Office.
- All patrons entering facility, whether swimming or not, must present pass to cashier or pay the daily fee.
- Extended family members such as grandparents, grandchildren, adult children, brothers, sisters, former spouses, uncles, aunts, cousins, in-laws and out-laws etc., not included under the definition of Family Member and not listed on pass application must pay the daily guest fee.
- Daily Pool Usage Fees:  
Monday thru Friday \$4 (Active Duty and their dependents with ID card), \$8 (Retired, Civilians, Guests)  
Saturdays/Sundays/Holidays \$8 (Active Duty and their dependents with ID card), \$10 (Retired, Civilians, Guests)
- Season Pass holders receive \$5 discount on swim lessons and \$2 discount on Wibit wristbands if present pass to cashier

## Pool Complex Rules

- Children 12 years and under must be accompanied by a parent or guardian (16 years or older).
- Children 12 years and under must pass swim test to be eligible to use diving board, slides and swim in deep ends of Figure 8 and 50 yard pools.
- Children 12 years and under who have not passed the swim test must be within arm's reach of a swimming parent/guardian (16 years or older).
- All non-swimmers must be actively supervised by a parent/guardian (16 years or older).
- No inflatable rafts, floats, or inner tubes permitted in any pool. Only swim noodles and United States Coast Guard (USCG) approved flotation devices are allowed.
- During Adult Lap Swim no one 17 years and under is permitted in or sitting on the side of pool. Parents/guardians are not permitted to sit on stairs or in water holding children, etc.
- Diving is ONLY permitted in water that is 9 feet or deeper. No running entries or flips from side are allowed.
- NO prolonged breath holding, running, pushing or horseplay permitted.
- Do not enter or swim when pool area is closed.
- Strollers must remain at shallow end of all pools and be at least four (4) feet from the water's edge.
- No coolers, outside food, glass or breakable items permitted within the boundaries of the Patton Hall Pool Complex.
- No refunds will be issued for pool closings due to inclement weather. Season Passes may be pro-rated by club management only upon presentation of PCS orders.

### Definition of Terms and Applicable Rules for all Passes

#### Definition of "Family Member"(in accordance with Army Regulation 215-1):

- a. Spouse of a sponsor.
- b. Unremarried widow or widower of a member or former member of a uniformed service.
- c. Unmarried child of a sponsor, including an adopted child, stepchild, foster child, or ward, who either—
  - (1) Has not passed his/her 21st birthday.
  - (2) Is incapable of self-support because of a mental or physical incapacity that existed before that birthday and is (or was at the time of the member's or former member's death) in fact dependent on the sponsor for over one-half of his/her support.
  - (3) Has not passed his/her 23rd birthday, is enrolled in a full-time course of study in an institution of higher learning approved by a Secretary of an executive department specified in 10 USC Section 1073, and is (or was at the time of the member's or former member's death) in fact dependent on the sponsor for over one-half of his/her support.
- d. Parent or parent-in-law of a sponsor who is (or was at the time of the member's or former member's death) in fact dependent on the sponsor for one-half of his/her support and residing in the sponsor's household.
- e. Exchange students residing with Families of US military personnel who are their sponsors, and "au pairs" residing with Families of US military personnel. (Documentation required at time of enrollment)

**Rule for "Single + 1" season passes:** includes individual applicant (sponsor) plus one Family Member.

**Rule for "Family" season passes:** includes individual applicant (sponsor) and all Family Members. Family Members under age 4 do not require a pass. All other Family Members will be issued individual passes. Family Members and guests 12 years old and under must be under the supervision of a parent or guardian at all times.
