All patrons entering the DFMWR Pool Complex, whether swimming or not, must present a season membership card to the cashier or pay the daily fee. Extended family members such as grandparents, grandchildren, adult children, brothers, sisters, former spouses, uncles, aunts, cousins, in-laws etc., not included under the definition of Family Member and not listed on the membership application must pay the daily fee.

Daily Pool Usage Fees (applicable to ages 5 year & above, if you do not have a seasonal membership) Monday thru Friday \$10/pp - Saturdays/Sundays/Holidays \$12/pp - Family Pass \$50 (up to 6)

## **DFMWR Pool COVID Mitigation Rules**

DFMWR Pool Complex will be limited to 152 patrons on a first come – first serve basis.

Only the 50 Yard and 25 Meter pools will be open for the 2021 season. Wading pool, Figure 8 pool, slides and diving board will be closed.

Fully vaccinated patrons are not required to wear face coverings for entry or within the DFMWR Pool Complex. Please continue to practice physical distancing from fellow patrons.

Patrons will <u>NOT</u> have access to locker rooms to change. Patrons must come dressed to swim - as locker rooms, lockers and showers will be unavailable. One shower in each locker room will be designated to rinse off for water entry. Toilet areas will be open for one person at a time or unless they are from the same family.

Seating is spaced out with family grouping areas to maintain physical distance of 10' between groupings. Patrons will not be allowed to change seating locations once designated and occupied.

Patrons will <u>NOT</u> be allowed to relocate or move furniture from designated grouping area.

Lap swimming will be restricted to no more than 3 swimmers per lane at one time. DFMWR has the right to adjust lap lanes as needed.

Patrons are required to maintain 10' distance within the water unless from the same family.

DFMWR will not issue swim noodles, kick boards, life jackets, etc.

No drinking water will be provided. Concessions will be available for patrons to purchase food and drinks. Patrons will need to maintain 6' physical distancing while in line for concessions.

DFMWR will provide hand sanitizer stations throughout the pool complex.

# **DFMWR Pool Complex Rules**

- Children 12 years and under must be accompanied by a parent or guardian (16 years or older).
- Children 12 years and under must pass a swim test to be eligible to use the diving board, slides and swim in deep ends of pools.
- Children 12 years and under who have not passed the swim test must be within arm's reach of a swimming parent/guardian (16 years or older).
- All non-swimmers must be actively supervised by a parent/guardian (16 years or older).
- No inflatable rafts, floats or inner tubes permitted in any pool. Only swim noodles and United States Coast Guard (USCG) approved flotation devices are allowed.
- During Adult Lap Swim, no one 17 years old or under is permitted in or sitting on the side of pool. Parents/guardians are not permitted to sit on stairs or in water holding children, etc.
- Diving is ONLY permitted in water that is 9 feet or deeper. No running entries or flips from side are allowed.
- NO prolonged breath holding, running, pushing or horseplay permitted.
- Do not enter or swim when the pool area is closed.
- Strollers must remain at the shallow end of all pools and be at least four (4) feet from the water's edge.
- No coolers, outside food, glass or breakable items permitted within the boundaries of the DFMWR Pool Complex.
- No refunds will be issued for pool closings due to inclement weather. Season Passes may only be pro-rated upon presentation of PCS orders.

#### Definition of Terms and Applicable Rules for all Seasonal Pool Memberships Definition of "Family Member" (in accordance with Army Regulation 215-1):

- a. Spouse of a sponsor.
- b. Un-remarried widow or widower of a member or former member of a uniformed service.
- c. Unmarried child of a sponsor, including any adopted children, stepchildren, foster children, or ward, who either—
  (1) Has not passed his/her 21st birthday.
  - (2) Is incapable of self-support because of a mental or physical incapacity that existed before that birthday and is (or was at the time of the member's or former member's death) in fact dependent on the sponsor for over one-half of his/ her support.
  - (3) Has not passed his/her 23rd birthday; is enrolled in a full-time course of study in an institution of higher learning approved by a Secretary of an executive department specified in 10 USC Section 1073, and is (or was at the time of the member's or former member's death) in fact dependent on the sponsor for over one-half of his/her support.
- d. Parent or parent-in-law of a sponsor who is (or was at the time of the member's or former member's death) in fact dependent on the sponsor for one-half of his/her support and still resides in the sponsor's household.
- e. Exchange students residing with Families of US military personnel who are their sponsors, and "au pairs" residing with families of US military personnel. (Documentation required at time of enrollment)

**Rule for "Single + 1" seasonal memberships:** includes individual applicant (sponsor) plus one Family Member/Significant Other.

**Rule for "Family" seasonal memberships:** includes individual applicant (sponsor) and all Family Members (up to 6). Family Members under age 5 do not require a seasonal pool membership. Family Members and guests 12 years old and under must be under the direct supervision of a parent or guardian at all times.
